

TERMS AND CONDITIONS

1. The monthly advance payments must be equal and paid continuously for eleven months
2. On completion of eleven months from the date of enrolment the member will be eligible to avail No Wastage(VA) on jewellery (Expert special items like Diamond, Platinum, Uncut Diamond, Ruby, Emerald Ethnic, Vintage, silver articles, jewellery) limited to the accumulated advance amount only or the accumulated gold weight based on the option chosen by the member (the advance payment cannot be extended beyond eleven months).
3. On completion of eleven monthly advance payments from the date of enrolment the member is eligible for purchase of jewellery
4. Cash will be not refunded under any circumstance, as per Government regulations.
5. Members Who choose to discontinue within 7 months of enrolment will not be eligible for any benefits, However if the member discontinue during 8th, 9th 10th month of enrolment, the member will be entitled to 60% of the wastage value on the jewellery purchased limited to the accumulated advance amount or accumulated Gold weight
6. Making Charges will be charged according to the type of jewellery purchased, and Wastage (VA) will be charged for special items as mentioned above.
7. The total advance amount paid will be refunded to the member without any benefit, if the member does not purchase jewellery.
8. When the member purchases jewellery in excess of accumulated amount in excess of accumulated Gold weight, the wastage (VA) as applicable will be borne by the member for the difference amount/weight.
9. GST (currently at 3%) & any other Government levies at the time of delivery will be borne by the member.
10. The member's signature will be verified at the time of delivery.
11. Company at its sole discretion can alter, amend, modify, add or delete any of the terms and conditions from time to time.
12. All disputes are subject to the jurisdiction of the complete courts in Hyderabad.
